Hazards from the substance or mixture Extremely flammable aerosol. Runoff to sewer may create fire or explosion hazard. 5.3 Advice for firefighters

Special protective actions for fire-fighters

6.1 Personal precautions, protective equipment and emergency procedures

For non-emergency personnel

6.2 Environmental precautions

6.3 Methods and material for containment and cleaning up

Small spill

Alternatively, or if water-insoluble, absorb with an inert dry material and place in an appropriate waste disposal container. Dispose of via a licensed waste disposal contractor.

Large spill
