SECTION 4: First aid measures

* **4.1. Description of first aid measures**

General information:

In case of accident or unwellness, seek medical advice immediately (show directions for use or safety data sheet if possible). Remove victim out of the danger area. Following inhalation:

5.2. Special hazards arising from the substance or mixture

During heating or in case of fire, toxic gases is possible.
